Legal / Lawful Overview

Over the course of the past two (2) or so years, the [Office of ‘Governor’ Ronald DeSantis] has been notified over several incidences, which took place in violation of national birthrights thus infringing upon international solidarity and integrity to all Nations of the Earth.

Since 26 January 2021 [A.D.], with the initial kidnapping of Ilhahi Ankaa Bey (fraudulently misidentified as ILHAHI A. BAY and / or ILHAHI ELBEY and / or other 'Man-of-Straw' variations by CITY OF ORLANDO and ORANGE COUNTY and LYNX operatives / employees), the matter was indeed brought to the attention of Ronald DeSantis and / or his administration for immediate rectification and remedy. Ronald DeSantis was given ample time to legally / lawfully address all matters pertaining to Ilhahi Ankaa Bey for remedy. However, he has failed to correspond and thus committed estoppel, with prejudice, against an Heir to the estate upon which his administration clearly operates from the said 'Tallahassee' [Florida] Republic region / territory.
